Hi Jeffersonians:

The El Dorado County State of Jefferson Committee, is excited to have John Cameron and Kaycee Royer of Pacific Legal Foundation as the guest speakers at our Tuesday, June 12, meeting at the American Legion Hall, 4561 Greenstone Road, in Placerville. Doors open at 5:30 PM, for social hour and Taco Tuesday Night, with all the fixings, beverages and desserts. Meeting starts at 6:30.

Since 1973, donor supported Pacific Legal Foundation (PLF) has successfully litigated for limited government, private property rights and free enterprise in the nation's highest courts, or, defending liberty and justice for all. In fact, PLF has had 9 victories in their 11 cases heard before the U.S. Supreme Court.

John Cameron is the Liberty Society Manager. After leaving the military and later graduating from CSUS, John had a successful run as a sales manager at Capital Cities/ABC and Disney. After 3 years with the company, he decided to go out on his own and started customsalestraining.com and theeffectiveleadershipcoach.com. John says he could handle the long hours and the vagaries of the economy, but what frustrated John most, was the massive government overreach. He wasn't a lawyer and didn't have the wherewithal to write a \$100,000 check, so when the opportunity came along to work as a developmental officer for PLF, he grabbed it.

Kaycee Royer is one of PLF's attorneys, who grew up on a rural ranch in Idaho and learned the importance of property rights and balanced environmental regulation. Kaycee graduated from the University of Idaho with an undergraduate degree in Agricultural Economics. After obtaining her undergraduate degree, Kaycee attended the University of Idaho's College of Law, obtaining a J.D. Cum Laude. She also served as the Chief Symposium Editor for the Idaho Law Review, hosting the largest symposium of the Review on the topic of livestock grazing on public lands.
